# Business and Related Skills and Experience

Since 1997 I have been co-ordinating and training coaching courses and running my own equestrian centre full time. We provide training & agistment for a wide variety of horses & riders and currently employ one working pupil per 12 months plus 1 casual stable hand. My first Level 1 course was run in 1997 and was the first of its kind. I wrote the entire course plan which took the candidate from the very beginning with a Train the Trainer course, through all the riding skills, stable management & coaching and finished with a mock exam and covered every aspect of the syllabus and all tasks were covered extensively. The course was fully documented, and candidates provided with a detailed timetable that outlined the curriculum for the ensuing 9 months duration plus regular feedback reports. I originally employed Level 3 specialist coaches to conduct the training before taking over some of the role myself when I became a Coach Educator.

This was a highly effective program and not only helped riders return to the sport they loved but kick started work for many coaches whose income was greatly damaged by the effect of fires.

In 2009 I received a volunteer award from the ACT Equestrian Association in recognition for my work in various areas mentioned above.

Personally I have competed in dressage and showing on several different horses including client's horses. I enjoy riding side-saddle and have been involved with strapping and riding endurance horses. I have also competed at lower level eventing and western pleasure as a young person.

I have taken a pure Arabian Mare to the National Championships twice and competed an Andalusian at National level over several years.

I have also competed at several Royal Canberra Shows and coached riders competing in various dressage and showing competitions.

My first job with horses was as a trainee groom at the Heythrop Hunt Stables where in my second season I was promoted to Head Girl. This gave me very good experience in survival riding and hunting a variety of green horses as well as organising and maintaining staff standards.

After that I trained overseas as a dressage/haute ecole rider with Joszi Smaha-Vinicky, returning to UK in the early 60s to become Chief Instructor at Trentham Riding School – one of only three Centres in UK at that time with an indoor arena! Whilst there I introduced

- a) a working pupil scheme preparing students for BHS accreditation and a career with horses and
- b) ran regular indoor show-jumping competitions both firsts at that time.

When I married 2 years later my husband and I developed and ran Shropshire Equestrian Centre, until 1985, where we trained riders from many parts of the world, preparing them for British Horse Society accreditation, competition riding, and for running their own Equestrian Centres; as well as developing their equestrian knowledge and riding ability, this training included people skills, management principles, short and long term planning, business and office skills, and many successful trainers and coaches 'graduated' from there; Richard Davidson, FBHS, Tim Downes, FBHS, William Blayne, FBHS, Islay Auty, FBHS, Odedde Shimoni, Dror Ben Shual, to name a few.

Under a further 'hat' our Equestrian Centre had a 'team' of Equestrian experts who were available for short and long periods, (up to 6 months) as advisers to established and/or planned Equestrian Centres and Riding Schools, internationally.

In the 60 plus years that I have been professionally involved in the equestrian industry I have been fortunate to have exposure to most forms of training and performance, including Trail-riding, flat and steeplechase racing, polo, fox and deer-hunting, dressage, Showing (ridden and In-hand), show-jumping, One and Three Day-Eventing, breeding, breaking and training young horses, re-training spoilt and problem horses — all of this has made me very aware of the need for the setting out and following of correct, appropriate and safe procedures in all aspects of the care and riding of horses.

As I have also spent most of this time training aspiring riders, coaches, teachers and horse handlers, I have written in depth and explicit Guidelines to cover as many aspects as I can for the multitude of possible scenarios.

As a Fellow of the British Horse Society, and an EA Level 3 Coach, I have been training grooms, horse handlers, Riding Teachers and Coaches for over 50 years, as well as teaching



and coaching from beginners to successful Olympic riders in Dressage, Eventing and Show-jumping. As a rider, I have successfully performed in One and Three Day Eventing, Dressage, Showing, Show-Jumping and Point-to-Point racing. I also performed as an Haute Ecole rider for several years in Germany, Holland, Sweden, France and UK.

I have ridden most breeds of horses and competed in dressage (to Grand Prix), Eventing (to International 3 Day Events) Showing (to HOTYS in UK), plus Show jumping, Point-to-Point riding, hunting and both breaking in and re-training many horses.



I have trained many riders to International level, Dressage and Eventing, both in UK and overseas – I travelled to Canada annually in the late 70s to work with their 3DE Event team, and I also coached their Junior National 3DE Trainer.

As BHS County Chairman I coordinated many of the local competitions and other equestrian activities – my husband and I also sponsored XC fences at Shropshire One and Three Day Events. I have acted as a Steward and Fence judge many times.

I did some dressage judging in UK, overseas and also in Australia, but decided to put my energy more into training people – I believe there are many good people out there judging.

As there are few centres in Australia where students can spend a year or more training for their chosen career in horses, I decided 20 years ago to develop an Equine Studies Course to be delivered to students while still at school – this is NSW Board of Studies approved as an HSC Course and has been delivered in northern NSW high schools since then, but has also accepted and trained many EA Intro and Level 1 coaches who enrolled as 'mature' students.

I have been running my own equestrian business, both in UK and since moving to Australia since the early 70s.

I have been Consultant Coach to Northern Rivers Equestrian Centre for 25 years.
